# d. <u>Exemption for Singaporean Citizens Contributing to India's Employees' Provident Fund</u> (EPF)

As per the India-Singapore Comprehensive Economic Cooperation Agreement signed in 2005, Singapore Citizens working in India do not need to contribute to India's Employees' Provident Fund (EPF). On 14 March 2017, the Employee's Provident Fund Organisation (EPFO) issued a circular to inform and remind all the EPF offices in India of the exemption.

To qualify for the exemption, Singapore citizens should provide their employers with a copy of their Singapore passport for verification by India EPFO. No other form or registration with EPFO is required for the exemption.
