11. The tender offers will be evaluated based on the following criteria and weightage assigned:

a.	Price competitiveness	45%
b.	Compliance with scope and specifications	20%
c.	Relevant experiences	15%
d.	Track record of Company	10%
e.	Management Support Plan	10%

12. The tender should remain valid for acceptance for a minimum period of Ninety (90) days from the closing date of this invitation.
